To round out the day, we will be having a Pub Crawl (complete with shuttle!) through the Mainstrasse area of Covington, KY, after judging is complete.

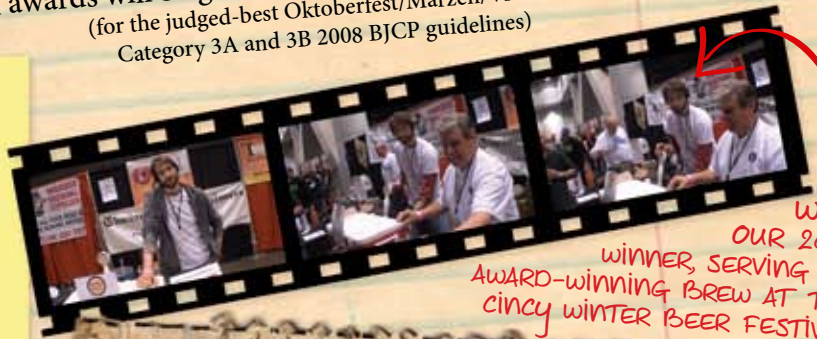
We will arrive back at the hotel in time for awards presentation and raffle drawings.

#### CONSIDERATIONS REGARDING "BEST OF SHOW" ELIGIBILITY FOR BREWING AT THE RIVERTOWN BREWING COMPANY AND RELEASE AT 2012 CINCINNATI WINTER BEERFEST

- The brewer of the "Best of Show" beer ("BOS beer") will be invited to brew a minimum of five barrels of their beer at The Rivertown Brewing Company, Cincinnati, Ohio; under the supervision of Rivertown's ownership, Rivertown Brewing.
- The brewer of the "BOS beer" is responsible for their own transportation to Cincinnati and their own accommodations. If the brewer of the "BOS beer" lives out of the area, cannot or does not wish to brew their beer themselves using Rivertown's facility, Rivertown will brew it for them.
- The recipe must be brewed and sold in accordance with all laws and regulations of the State of Ohio. BOS winner will agree to collaborate with Rivertown Brewing to make any needed recipe modifications to remain in compliance with the laws and regulations of the State of Ohio.
- The BOS winner agrees to collaborate with Rivertown Brewing in regard to schedule and brewing process.
- If the brewer of the "BOS beer" does not wish to have their beer brewed, then a special panel consisting of CMI's Competition Director, CMI's President, Rivertown's Ownership and the Organizer of the Cincy Winter Beerfest will be convened. Said panel may not select additional judges to fill the remainder of the panel at their sole discretion. Said panel will select a beer to be brewed from one of the others that placed in the "Best of Show" flight. Any judge with a beer being considered must be excused from this panel.
- The brewer of the Oktoberbest 2011 "BOS beer" agrees to allow their name, likeness and beer recipe name/description to be used by Rivertown Brewing, Cincy Winter BeerFest, and Cincinnati Malt Infusers for promotional purposes.
- Oktoberbest 2011 "BOS beer" winner must agree to license Rivertown Brewing to produce the Oktoberbest 2011 "BOS beer" for the purpose of distribution at the Cincy Winter Beerfest or events promoting it's appearance at the Cincy Winter Beerfest. BOS winner will retain recipe ownership.
- These considerations are subject to change without prior notice, at the discretion of the CMI Oktoberbest organizational committee.
